**Steps to be Taken in Case Material is Released or Spilled:**

wear respirator, chemical safety goggles, rubber boots and heavy rubber gloves. Sweep up, place in bag and hold for waste disposal. Avoid raising dust. Ventilate area and wash spill site after material pickup is complete.

**Waste Disposal Method:**

dissolve or mix material with a combustible solvent and burn in a chemical incinerator equipped with an afterburner and scrubber. Observe all federal, state and local environmental regulations

**Precautions to Be Taken in Handling and Storage:**

Avoid contact and inhalation. Keep tightly closed. Restrict handling by unqualified personnel. Store in a Freezer, avoid prolong, repeated exposure. wash after handling
