Symptoms may include headache, hypoeesthesia, peripheral neuropathy, paresthesia, tremor, fatigue, vertigo, insomnia, sexual dysfunction, nervousness, somnolence, depression, abnormal dreams, anxiety, depersonalization, abnormal vision, conjunctivitis, diplopia, eye pain, tinnitus, dyspnea, epistaxis, micturation frequency, micturition disorder, acute renal failure, acute tubular necrosis, nocturia, leukopenia, thrombocytopenia, purpura, arthralgia, arthrosis, muscle cramps, back pain, rigors, myalgia.
